



**Community Reinvestment Area Program

**PROGRAM DESCRIPTION**

The Community Reinvestment Area Program provides real estate property tax abatements on the increased assessed value from an investment in property improvements. Taxes are abated for the maximum period specified below for increases in property values added to tax rolls after a project is certified. To qualify for the abatement, the applicant must make an investment in real estate meeting the following thresholds:

	<b>\$25,000 to \$50,000</b>	<b>\$50,000 to \$100,000</b>	<b>\$100,000 or more</b>
<b>Commercial and Industrial Project</b>	<b>5 Years 100 % Exemption</b>	<b>8 Years 100% Exemption</b>	<b>15 Years 100% Exemption</b>

The Development Department will verify the project, inspect the premises before and after completion of the project and certify the project. After the project has been certified, the Development Department will inform the County Auditor. After projects are certified, projects will be annually reviewed by the Development Department to ensure that all improvements are in good repair and meet applicable codes and standards.
