# MINUTES CIVIL SERVICE MEETING THURSDAY, JULY 10, 2008

The Civil Service Commission met at 6:30 p.m. in the Municipal Government Complex Commission Chambers, located on the second floor at 201 W. Water Street.

## REGULAR CIVIL SERVICE MEETING

#### Minutes of May 7, 2008

Bruce Hogston moved to accept the minutes of May 7, 2008 and Alissa Blankenship seconded the motion. All members were in favor and motion carried unanimously.

#### **Extension of Eligibility List**

Mike Gutmann asked for clarification regarding the extension of the lists. Elaine Barton explained that the lists were certified for a one year period but according to the rules, could be extended for one year. Mr. Gutmann made a motion to extend both lists (police officer and firefighter) for one year and Bruce Hogston seconded the motion. All members were in favor and motion carried unanimously.

### **School Board Rules**

Clayton Brown asked if we currently receive a School Board eligibility list. Elaine said that she would follow up on this request with Tim Reed.

The rule changes requested at the meeting on May 7, 2008 were as follows:

Tim Reed, Piqua City School Business Coordinator, requested the board to change the language in Rule III, Section 2 (c) of the Piqua City School's Rules. He requested the title of Administrative Assistant be changed to Business Coordinator.

Mr. Reed also asked that Rule III, Section 2 (d) the position of Secretary be changed to Payroll Clerk. Also, in Rule III, Section 2 (i), the Food Service Secretary will assume human resources and civil service responsibilities. The Business Coordinator would no longer handle this.

Alissa Blankenship had pointed out that Rule II Sec 1(A) stated the civil service commission consists of 3 members and it needed updated to five.

All of the above changes were integrated into the School Board Rules. Bruce Hogston made a motion to accept the new rules as presented. Alissa Blankenship seconded. All members were in favor and motion carried unanimously.
