RESOLUTION NO. R-95-20

A RESOLUTION SUPPORTING THE DAVIDSON FLEXIBILITY FOR STATES AND LOCALITIES ACT AND DECLARING AN EMERGENCY

WHEREAS, the City of Piqua has experienced significant loss of revenue related to the impact of the Coronavirus pandemic; and

WHEREAS, the US Government, in response to the Coronavirus pandemic, passed the CARES Act and associated measures to support entities that suffered loss as a result of the Coronavirus pandemic; and

WHEREAS, the CARES Act funding restricted how State and Local agencies spent the funding and did not allow for flexibility to offset loss of revenue and associated budget shortfalls; and

WHEREAS, the Davidson Flexibility for States and Localities Act would allow local governments to utilize their remaining funding to offset budgetary shortfalls related to Coronavirus; and

WHEREAS, this would be welcome news for the City of Piqua and for all local governments in the State of Ohio in order to continue to provide services and support to citizens in a time of large funding shortfalls due to Coronavirus.

NOW, THEREFORE, BE IT RESOLVED, by the Commission of the City of Piqua, Miami County that:

SEC. 1: Piqua City Commission having reviewed the CARES Act and associated measures as well as the Davidson Flexibility for States and Localities Act, does urge and support the passage of the Davidson Flexibility for States and Localities Act. This Act is necessary and will provide critical flexibility for the City of Piqua and many other municipalities. The City of Piqua urges all appropriate elected officials to pass this legislation.

SEC 2: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare, to wit: to provide Piqua City Commission's support of this measure prior to it being voted on, and shall take effect and be in force from and after its adoption.
